

# COMPEER FINANCIAL DAY OF GIVING CONTEST TERMS & CONDITIONS

**ELIGIBILITY:** The Giveaway is open only to persons who are a legal resident residing in Illinois, Minnesota or Wisconsin and are eighteen (18) years of age or older at time of entry (the "Entrant"). Business entities are not eligible to participate. Officers, directors, managers and employees (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Compeer Financial (the "Sponsor") and each of their respective parents subsidiaries, affiliates and related companies, licensees, distributors, retailers, dealers, printers, advertising and promotion agencies, consultants and agents, and any others engaged in the development, production, execution or distribution of this Giveaway are not eligible to participate or win a prize. Then, click the "Submit" button to receive one (1) entry into the Giveaway. In order for an entry to be valid, Entrant must have a valid e-mail address and must click the "Enter Now" button.

**Limit of one (1) entry per Entrant/email address for the entire Giveaway.** Entrant must complete and submit all required information to be eligible to enter. Entries having incomplete information will be disqualified and ineligible to win.

Neither Sponsor nor any Giveaway Entity is responsible for any entry that is late, misdirected or undeliverable, due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

**PRIZES:** Three prizes shall be awarded, one for entries from each of Illinois, Wisconsin and Minnesota, each of which allow the winner to designate a \$2,500 donation to an FFA chapter, 4-H club, county fair or food pantry (each a "Eligible Organization" and collectively, "Eligible Organizations") in their respective state. Winners must designate the donation go to an Eligible Organization in their state but may choose from all Eligible Organizations in their state.

**WINNING:** The prize winner(s) will be selected in a random drawing, with one winner being chosen from entrants in each of Illinois, Minnesota and Wisconsin, respectively. Odds of winning a prize depend upon the total number of eligible entries received in each state during the Giveaway Period and are equal to one divided by the total number of valid entries received from each state.

**PRIZE RESTRICTIONS:** Limit of one (1) Prize per person/household. No Prize substitution, except at Sponsor's sole discretion or as otherwise provided herein.
