ELIGIBILITY: The Let's Get Digital Giveaway ("Giveaway") is open only to natural persons who are a legal resident residing in Illinois, Minnesota or Wisconsin and are eighteen (18) years of age or older at time of entry (the "Entrant"). Business entities are not eligible to participate. Then, click the "Submit" button to receive one (1) entry into the Giveaway. In order for an entry to be valid, Entrant must have a valid email address and must click the "Enter Now" button. Entrant must complete and submit all required information to be eligible to enter. Entries having incomplete information will be disqualified and ineligible to win. **Limit of one (1) entry per Entrant/email address for the entire Giveaway.** In order for to be valid, an entry must be submitted by 11:59 p.m. CT on March 31 2021.

In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the e-mail address by an Internet access provider, on-line service provider, or other organization that is responsible for assigning e-mail addresses, or the domain associated with the submitted e-mail address. Potential Winner(s) may be required to show proof of being the authorized account holder.
